### **BIOGRAPHICAL SKETCH**

John Freeman Schermerhorn was born in New York on September 24, 1787. He preached in Andover, Massachusetts, and in married Catherine Yates (1788-1835) in 1813. They had eight children: Christopher (1814), Harriet (1815- ), Mary Y. (1817-), Catherine Y. (1819-1839), Bernard (1821-1883), John Ingold (1824- ), Sarah Ingold (1826- ), and Ynsana Y. (1829- ). In 1837, he married again to Elizabeth L. Spottswood of Virginia, and they had three children: William Waller (1838- ), Catherine Virginia (1841- ), and Janette Egmont (1844- ).

slander and western lands. Correspondence from friends concerning Catherine's trip to Washington, D.C., treaty, health, teaching and death. After her visit to Washington until her death in 1839, Catherine received many letters from N.G. Ellsworth concerning the death of her mother, her stepmother, the move west, charges against J.F. Schermerhorn, and personal news.

1840-1865. Schermerhorn family letters concerning the move to Indiana in 1840, death of Catherine, lands, financial troubles, health, personal news, and birth of Mary's son. Mary married Demas K. Ward. Letters written to Kate Ward during the Civil War years from Union soldiers and family. These concern the war; southern women; Atlanta, Georgia; Chicago, Ill.; death and personal news. Several are from John D. Meredith whom she married in 1866.

1866-1906. Letters to Katie Ward Meredith from her husband and friends concerning books, bachelorhood, collecting taxes, personal news and John's death, 1870. Documents pertaining to John D. Meredith's estate and Demas K. Ward as Notary Public of Marion County, Missouri. Recommendations that Henry E. Meredith be commissioned a 2nd Lieutenant, U.S. Army. Correspondence and documents pertaining to the attempt of John F. Schermerhorn's heirs to recover his Virginia lands.
