INTRODUCTION

The collection contains correspondence, clippings, photographs, diaries, and bound material on the George family, Quantrill, William H. Gregg, and civil rights, compiled and authored by a native of Jackson County, MO, whose father served in the Civil War under Quantrill.

The collection was donated to the State Historical Society of Missouri by B. James George, Sr. in 1965 (Accession No. 262). Additions were made on 16 May 1974 (Accession No. 1076), 14 February 1975 (Accession No. 1124), and 20 November 1975 (Accession No. 1173) by B. James George. Additional materials were donated on 16 February and 26 March 2004 (Accession No. 6022).
