- f. 1-19 Accounts. Boone County National Bank cancelled checks, check stubs, deposit slip. Rent, water, and light dept., bills and P.O. box rental receipts. Sales receipts for refreshments, office supplies, lumber, paint, hardware, jewelry, printing work and other miscellaneous work. Pages from ledger account book.
- f. 20 Correspondence. Letter to Herbert Kaplan from Joe Clarety and Gil Harrison discussing finances of the national organization; letter to James N. Primm from H. Kaplan about his new post as secretary of the local chapter, remarks about the local politics of Philadelphia, PA. Letter to Harold Winer from Clifford Doucer giving the latter's views on establishing a university chapter. Letter to Harold Winer from Stephen B. Lobunski offering assistance in establishing a university chapter. Letter to chairman of local chapter from Mrs. E.M. Loomis thanking the organization for their Christmas donation to the Social Service Society of Columbia, Missouri.
- f. 21-27 Lists of members in good standing. Lists of members delinquent in payment of national dues. Mailing rosters; standing committees, lists of local dues payments, national transmittal form lists.
- f. 28-32 Cards indicating: members in good standing (financially), members owing national dues, out-of-town members whose membership has not expired, former members who have left town and whose dues have expired.
- f. 33-35 Subscription cards and receipts. Application cards for membership and the A.V.C Bulletin. Cards acknowledging receipt of membership dues.
- f. 36-41 Minutes of Meetings. Copy of the American Veteran's Committee Constitution and national by-laws. Booklet report on the third annual national convention, Nov. 1947. Minutes of the local chapter meetings (Nov. 18, 1947 to May 11, 1948), minutes of the national planning committee meeting, Sept. 1949-Feb. 1950.

- f. 42-51            Reports, Instructions, and Form Letters. Reports of activities of the local and national organization. Drives publicizing affairs of concern to veterans (National Housing Conference, Feb. 29, 1947). Instruction reports, and forms on membership campaigning, clue collection, meetings and election technique, membership renewals, transfers, copies of the A.V.C. national office newsletters. Copies of Veterans Administration publications of veteran's benefits. Copy of citizens committee for the Hoover report bulletin. Pamphlets on the A.V.C. civil rights, legislation. Brotherhood Week, and the Columbia River Dam development.
