Correspondence, diaries, photographs, financial and business records of Cross, an early Kansas City architect, and his immediate family.

BIOGRAPHY:

Asa Beebe Cross, son of Thomas B. and Millicent Beebe Cross, was born in Camden, New Jersey on December 9, 1826. Cross moved to Missouri in the 1850s where he first lived in St. Louis and studied architecture with John Johnston. While in St. Louis, Cross became associated with Mathew Rippey who owned and operated a lumber yard. In 1858, Cross relocated to Kansas City where he opened A.B. Cross & Co., a lumber yard, in association with M. Rippey and Company and in partnership with George Rippey.

Cross gradually shifted his business emphasis from lumber sales to building as an architect and contractor. He was joined in business by his stepson, William E. Taylor, Jr. who specialized in railroad construction until his death in 1883 at age 27. Cross was a noted architect who built many of Kansas City's public and private buildings. A list of some of those buildings is appended to this inventory.

Just prior to his move to Kansas City, Cross married Rachael Genevieve Taylor, a young widow with a small son, William E. Taylor. Asa and Rachael Cross produced five children: Frank and Louis died in infancy; Elizabeth (Lizzie), Catherine (Kate), and Mary Emma (Emma) survived both of their parents. Rachael Cross died July 24, 1890 and was followed by Asa B. Cross on August 18, 1894.

Lizzie Cross married Walter L. Ray and was living in Cincinnati at the time of her father's death. Mary Emma Cross never married and was buried in Kansas City on March 3, 1934. Catherine (Kate) Cross (December 19, 1866-March 29,

1924) married Alfred E. Barnes (December 5, 1869-November 1928) from London, England on July 3, 1891.

Alfred E. Barnes, Sr. worked with his father-in-law on the construction of the Jackson County Court House before moving to Texas and the Southern United States to continue his construction career. Kate Barnes remained in Kansas City where she raised her two sons, Alfred E. Barnes, Jr. (March 5, 1892-May 11, 1960) and Asa B.C. Barnes (September 9, 1894-February 13, 1991). Alfred E. Barnes, Jr. became a partner in the architectural firm of Hoit, Price, and Barnes, which built a number of prominent Kansas City buildings. While Alfred specialized in design, Asa B.C. Barnes specialized in construction and engineering.

PROVENANCE:

The Asa Beebe Cross Papers were acquired by contract from Mrs. Alfred E. (Clara) Barnes. These papers were received in batches and accessioned as KA0114 and KA0115 on October 1, 1981; KA0156 on July 14, 1982; KA0163 on August 16, 1982; KA0166 on August 26, 1982; and KA0177 on September 29, 1982. Also, one volume of the Kate Cross diaries was given by her son, Asa B.C. Cross as accession KA0203 on April 1, 1983.

DESCRIPTION:

This collection contains papers relating to members of the Cross family and to the descendants of A.B. Cross through Catherine Cross Barnes. The majority of the material was kept by Catherine Cross Barnes and so includes papers concerning her two sons, Alfred E. Barnes, Jr. and Asa B.C. Barnes.

The collection includes account books for the A.B. Cross and Company Lumber Yard, correspondence from family members and a volume of business related letters pertaining to the career of William E. Taylor, Jr. Photographs include portraits of the Cross family and friends.

Also within the collection are diaries kept by Kate Cross before her marriage. The diaries deal with the daily activities of the Cross family and incidents which occurred in the Kansas City area. Kate Cross also maintained clipping books which held news articles related to Cross and Taylor architectural plans and projects as well as more personal items. Numerous newspapers were also within the collection. A full list of these papers is appended to the Inventory and pertinent articles have been photocopied and placed within the collection. The original newspapers are available on microfilm and in other areas of the University of Missouri at Kansas City Miller Nichols Library.

The Alfred E. Barnes Architectural Records Collection (KC0004) of Western Historical Manuscript Collection-Kansas City is a related collection which deals with the firm of Hoit, Price and Barnes and the predecessor firms Van Brunt and Howe; Howe, Hoit and Cutler; and Howe and Hoit. Another related collection located in Special Collections at the University of Missouri at Kansas City Miller Nichols Library contains books which belonged to the Cross and Barnes Collections. Brief notes concerning these books are appended to the inventory.

The next section dates 1878 and covers 8 pages. There are both name and type of entry headings. The remainder of the volume is blank.

The next portion is dated April and May of 1872 and gives accounts by name of client. These are debit entries only and only one entry is made for each account. The remainder of the volume was used as a stamp collection album by Alfred E. Barnes, Jr. The name of William E. Taylor is inscribed in the front of the volume.
