Kansas City's Ten-Year Plan Records [Native Sons Archives] 1870-1938 (bulk: 1921-1940) 73 folders

Records relating to the depression era bond issue that resulted in the construction of a number of civic buildings and community improvement projects in Kansas City MO. Includes research, drafts, and photographs for the book, Where the Rocky Bluffs Meet: The Story of the Kansas City Ten-Year Plan.

HISTORY:

Where the Rocky Bluffs Meet: The Story of the Kansas City Ten-Year Plan was originally intended to convey the story of the Ten-Year Plan as it was conceived and conducted by the Chamber of Commerce, and more specifically by the Civic Improvement Committee (or the Committee of 1000) under the General Chairmanship of Conrad H. Mann. Conrad Mann served as President of the Chamber of Commerce from 1928-1934 and was drafted by Mayor Bruce B. Smith and City Manager H.F. McElroy to lead the Ten-Year Plan Movement.

It was quickly realized that the Ten-Year Plan was not an isolated activity and that the story could not adequately be told without the context of the activities and events that preceded it. Ray W. Wilson, Civic Secretary of the Chamber of Commerce and Executive Secretary of the Civic Improvement Committee, devoted over a year to collecting this data (much of it has his name on it) and compiling it with the help of numerous others in the form of a book. Thus, out of the initial idea to record this one particular plan spanning from 1931-1941 was born the history of Kansas City's public improvement endeavors.

The Ten-Year Plan was a coordinated effort to help Kansas City organize city improvements. It was officially launched in 1931 during the mayoral administration of Bryce Smith, with Henry F. McElroy as City Manager, although there had been talk of such a plan by other mayors. There were also earlier drives for civic improvements.

The Ten-Year Plan had beginnings in the "Get-it-Done" Committee of the Chamber of Commerce started in 1921 with F. C. Sharon, who was President of the Chamber of Commerce at the time. In 1920, following World War I, it was recognized that hospitals, streets, schools and fire protection were inadequate in Kansas City. Improvements were needed for parks and boulevards.

The "Get-it-Done" committee did not initiate new improvements, but pushed to complete projects started under the tax bill method, which was special assessment against real estate within the benefit district. It was not just a Chamber of Commerce program but one that involved city-wide cooperation. Some projects that were completed were the widening of Main Street and Broadway, the opening of Twenty-third and Sixth Street Trafficways, the installation of a modern lighting system, and others.

It was recognized that the tax bill system was inadequate and that bonds needed to be passed. The "Get It Done" committee recommended preparations of "a comprehensive program covering the needs of Kansas City for physical public improvements for a definite term of years under which these would be financed in accordance with their need and the city's ability to pay, through bond issues, special assessments and from current revenues."

During the 1920's, several bond issues were presented to the voters, but few passed. Some voters felt that the issues had not been investigated sufficiently and that pertinent information was not brought out. Long-term planning was advocated by the Civic Research Institute, the Chamber of Commerce and Mayors Cromwell and Beach. In 1929, Mayor Beach and City Manager McElroy appointed a committee of 100 citizens to study and present programs for public improvement. When Bryce Smith was elected mayor in 1930, he and McElroy followed through and appointed Conrad Mann, President of the Chamber of Commerce, as general Chairman of the Ten-Year Plan organization.

Conrad Mann, originally from Milwaukee, was secretary and general manager of the Kansas City Breweries Company. He expanded the committee of 100 to a committee of 1000. Many notable Kansas Citians became involved such as J.C. Nichols, James A. Reed, H.M. Langworthy, N.T. Veatch, Jr., R.E. McDonnell and others. Some of the projects accomplished during this time were the Municipal Auditorium, City Hall and County and Federal Courts and Post Office buildings; the paving of Brush Creek and other sanitary and sewer projects; improvements of trafficways, boulevards and streets; additions at the airport; and others.
