This volume includes minutes of meetings, a roster of members and visitors, and miscellaneous papers of Campbell Camp No. 488, United Confederate Veterans, at Springfield in Greene County, Missouri.

Campbell Camp No. 488 at Springfield was organized on March 6, 1894. Its records include discussions of admittance of members to the Confederate Home at Higginsville, Missouri, and the relief of needy veterans, resolutions on the deaths of members of the camp, and documents regarding the controversial disbursement of funds collected to defray the expenses of the statewide reunion of the United Confederate Veterans held at Springfield in 1915.

An earlier record book of the Campbell Camp, for the years 1894-1915, has been cataloged as Western Historical Manuscript Collection-Rolla collection R060.
