INTRODUCTION

The Bangert family papers chronicle two generations of the Bangert Family. They consist mostly of the personal papers of Nell Mabrey Bangert and the genealogy and family photographs of her husband's family.

BIOGRAPHICAL SKETCH

Nell Mabrey was born September 24, 1910, in Chaonia, Missouri, to George and Esther Mabrey. She attended Center Ridge Elementary and Greenville High School, both in Wayne County. After graduating high school, Mabrey attended and graduated from Southeast Missouri State Teachers College, now Southeast Missouri State University, in Cape Girardeau. Mabrey taught at Advance Public High School in Advance, Missouri, and also worked as a file clerk at the FBI in Washington DC. Mabrey married Herb Bangert on June 10, 1945. Bangert (1907-1974) was from Cape Girardeau County. He worked as an iron molder in a foundry and belonged to the Free Masons. They had no children and he passed away suddenly in 1974. Nell never remarried. She died January 25, 1996, at the age of 85.

The Bangert Family Papers consist of the family photographs, educational materials, and family history of Herb and Nell Mabrey Bangert. The collection is organized topically and where possible, chronologically.
